1. Purpose and Institutional Commitment

2. Definition of Hazing

Hazing is defined as any activity that humiliates, degrades, abuses, or endangers a student to join or remain in a group, regardless of their willingness to participate. It can be subtle, involving harassment, or overtly violent, and includes activities like sleep deprivation, emotional abuse, forced consumption of substances, social isolation, and morally questionable quests. It encompasses activity that is likely to cause harm and is often tied to membership in a student organization, whether officially recognized or not.

Examples of hazing activity include, but are not limited to, the following:

Subtle: Social isolation, depriving members of privileges, public displays of unusual clothing
Harassment: Threats or implied threats, verbal abuse, morally questionable quests or treasure hunts
Violent: Activities causing excessive fatigue, physical or psychological shocks, or requiring public stunts
